Arrival – Lodging – Administrative Paperwork

There is a number of administrative errands to do before the beginning of the courses. One of them is to register with Interpol and then the Chilean Civil Registry Office which will provide you with an ID to be used in your errands in the whole country as well as in the university

Upon Arrival	Register with Interpol. This can be done at the airport immediately upon arrival or at the available offices in the city https://www.policia.cl/extranjeria/portada.htm
Please consider that these errands are highly demanded so you should consider a long waiting time.	Once the above errand is concluded, you have to show the document at the Civil Registry Office to obtain the Chilean ID for Foreigners. https://www.srcei.cl/ (1570 Huerfanos Street.
